Boudoir Studio Confidentiality Policy Agreement

Note: This document may be adjusted on case-to-case basis.

This Confidentiality Policy Agreement ("Agreement") is made and entered into as of the date signed below by and between:

Boudoir Studio ("Photographer") and **[Client's Full Name]** ("Client").

Both parties agree to the following terms regarding the confidentiality and privacy of the Client's photoshoot:

1. Confidentiality Commitment

The Photographer agrees to:

- 1.1. Keep all verbal, written, and digital communications with the Client strictly confidential.
- 1.2. Not disclose the Client's identity, personal details, or any discussions related to the photoshoot to any third party without explicit written consent from the Client.
- 1.3. Ensure that no photos or videos captured during the session, including those featuring suggestive poses, are shared, published, or used for promotional purposes without the Client's prior written permission.

2. Limited Access to Content

- 2.1. All images and materials from the photoshoot will remain stored in a secure, password-protected system accessible only to the Photographer.
- 2.2. If editing or post-production is outsourced, the Photographer will ensure the third-party editor adheres to the same confidentiality standards.

3. Client Consent

- 3.1. If the Client agrees to allow the Photographer to use certain images for promotional or portfolio purposes, a separate consent form will be provided, specifying the exact images and their intended usage.
- 3.2. The Client retains the right to withdraw consent at any time, and the Photographer will promptly remove the images from use.

4. Non-Disclosure by the Client

4.1. The Client agrees not to disclose sensitive business information or trade secrets about the Photographer's process, pricing, or proprietary methods to third parties.

5. Liability

5.1. The Photographer is not responsible for breaches of confidentiality caused by unforeseen circumstances, such as hacking, provided all reasonable security measures were taken.

5.2. The Photographer will take all appropriate actions to rectify any accidental breach should it occur.

6. Governing Law

This Agreement shall be governed by the laws of **Mauritius**, and any disputes arising from it shall be subject to the jurisdiction of Mauritius.

7. Duration of Confidentiality

This Agreement remains in effect indefinitely unless otherwise agreed in writing by both parties.
